Update on the Overseas Projects of Shriram EPC

The USD 236 Mn (Rs.1675 crores) for Sewerage Water, Storm Water and Trunk Sewer Pipeline Project along with Civil Works and Road Works at Al Qibla area, Basra, for Basra Governorate that was restored to the Company in November 2018(as already informed to the stock exchanges on 1/11/2018) is progressing ahead of schedule. The first phase of the project was completed in September 2019. The project is scheduled for completion in 2020.

The overseas project valued at 240 M US D (Rs.1700 crores) for a 1.2 MTPA Mini Mill Project in Sohar, Sultanate of Oman through its 100 % subsidiary, SHRIRAM EPC FZE, SHARJAH is in advanced stage of completion. Commissioning is expected this Financial year.

The Overseas contract for an amount of 107 M USD (Rs.760 crores) with L & T as the major JV partner from the Ministry of Water & Irrigation United Republic of Tanzania for the extension of Water transmission pipeline from the Lake Victoria Water supply scheme to Tabora, Nzega and Igunga Towns, Package II, through EXIM Bank line of credit is in the advanced stage of completion.
