Sub: Outcome of the Board Meeting under Regulation 30 read with Part A of Schedule Ill of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to the implementation of the Resolution Plan as approved by the Hon'ble National Company Law Tribunal, Hyderabad Bench ('approved Resolution Plan') vide its order dated 03rd December, 2020, we hereby inform that the Board of Directors of the Company has at its Meeting held today, i.e. on Saturday January 30, 2021, inter-alia:

- 1. Considered and approved the alteration of Object Clause of the Memorandum of Association (the "MOA") of the Company by substituting the new Object Clause in the place of existing Object clause, subject to the approval of the Registrar of Companies, to carry and for furtherance of the activates as envisaged in the Resolution Plan.

- 2. Considered and approved the change of Company name from Proseed India Limited to "Equippp Social Impact Technologies Limited", subject to the approval of the Registrar of Companies, in order to reflect the business activates in the name of the Company as envisaged in the Resolution Plan and for consequent alterations in the Memorandum of Association ('MOA') and Articles of Association ('AOA') of the Company.

The name is made available by the office of the Registrar of Companies, vide its letter dated January 27, 2021.

It is pertinent note that as per the terms of the Resolution Plan, the Company contemplates to carry Information Technology and related ITes services in the Company replacing existing business activities by altering the Object Clause of the Company. It is also proposed in Resolution Plan to change the name of the Company suitably to another name to reflect the new business activities in its name.

Please note that the aforesaid alterations in the Object Clause and Name Clause and consequent alterations in the Memorandum of Association ('MOA') and Articles of Association ('AOA') of the Company is being undertaken pursuant to the implementation of the approved Resolution Plan and
