Farmers' advocate Nageswara Rao has said that he will seek cancellation of UltraTech's mining licence in the NCT of Delhi. He said that the licence was granted to UltraTech without any environmental clearance and that the company is violating the provisions of the Environmental Protection Act, 1986.
