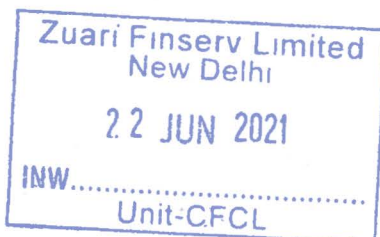


Sub: Issue of duplicate share certificate
