Independent Auditor's Review Report on unaudited financial results for the quarter and year to date period ended December 31, 2024 of Multibase India Limited pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

To The Board of Directors of Multibase India Limited

- We have reviewed the accompanying statement of unaudited financial results of Multibase India Limited ('the Company') for the quarter ended December 31, 2024 and the period from April 01, 2024 to December 31, 2024 ('the Statement') attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('the Regulations').
- 2.
