Singapore: Preliminary findings released on Wednesday of an investigation into a Singapore Airlines (SIA) flight hit by severe turbulence last week showed a rapid change in gravitational force and a 54-metre altitude drop that caused injuries among

passengers. A 73-year-old passenger died of a suspected heart attack and dozens were injured after flight SQ321, flying from London to Singapore, encountered what the airline described as sudden, extreme turbulence while flying over Myanmar.



'ISRAEL DID NOT CROSS RED LINE'

The US does not believe Israel has launched a full-scale invasion of Rafah in southern Gaza, White House spokesman John Kirby has said. He spoke hours after Israeli forces reached the centre of the city and reportedly seized a strategically important hill overlooking the nearby border with Egypt.



US President Joe Biden said this month he would limit weapons supplies to Israel if it entered the "population centres" of Rafah, where hundreds of thousands of civilians are still believed to be sheltering.

Questioned about an Israeli strike and a resulting fire that killed at least 45 Palestinians - many of them women, children, or elderly - at a camp for displaced people on Sunday, Kirby described images from the aftermath of the strike as "heartbreaking" and "horrific".

Israel has maintained that the strike targeted and killed two senior Hamas officials, and that it believes the fire could have been caused by an explosion at a Hamas weapons store nearby.

Asked whether the strike had violated the limits previously set by Presi-

dent Joe Biden, Kirby said he had "no policy changes to speak of". "We don't support, we won't support a major ground operation in Rafah," he said. "The President said that, should that occur, then it might make him have to make different decisions in terms of support. We haven't seen that happen at this point. We have not seen them smash into Rafah," he added.

A day after Washington said the assault did not amount to a major ground incursion of the southern Gaza city, a report from Cairo said that Israeli tanks conducted a second day of probing attacks across Rafah on Wednesday.

Israeli tanks advanced to the heart of Rafah for the first time on Tuesday after a night of heavy bombardment. Unlike tactics used in Israel's ground offensive in the rest of the enclave, Rafah residents said Israeli tanks mounted raids into Tel Al-Sultan in western Rafah and Yibna and near Shaboura before retreating to positions near the border with Egypt.

Hamas and the Islamic Jihad said they confronted the invading forces with anti-tank rockets and mortar bombs, and blew up previously planted explosives.

Black female MP can't run for Labour

UK's first-ever black female member of parliament (MP), Diane Abbott, has said she is "banned" from standing as a Labour candidate in the July 4 election after she was suspended more than a year ago for comments about Jews and racism.



Abbott was first elected to parliament for Labour in 1987 and, as the country's longest serving Black MP, had campaigned on issues such as racism, poverty and international affairs in her district in north east London. She was a close ally of Jeremy Corbyn who led the party from 2015 to 2020, when it was accused by the equalities watchdog of unlawful acts of harassment and discrimination against Jews. Corbyn was replaced by Keir Starmer who has sought to purge the party of some of its left wing members, and tackle any allegations of anti-semitism.

"Although the whip has been restored, I am banned from standing as a Labour candidate," Abbott told the BBC, referring to her reinstatement as a Labour MP after her suspension.

Putin warns West on weapons to Ukraine

NATO members in Europe are playing with fire by proposing to let Ukraine use Western weapons to strike deep inside Russia, Russian President Vladimir Putin has warned the West.

The warning comes as some NATO members recently pledged military aid to Ukraine.

More than two years into the deadliest land war in Europe since World War Two, Putin has increasingly spoken of the risk of a much broader global conflict as the West grapples with what to do about the advance of Russian troops in Ukraine.

NATO Secretary General Jens Stoltenberg told The Economist that alliance members should let Ukraine strike deep

into Russia with Western weapons, a view supported by some NATO members but not by the US.



"Constant escalation can lead to serious consequences," Putin said in Tashkent. "If these serious consequences occur in Europe, how will the United States behave, bearing in mind our parity in the field of strategic weapons? It's hard to say - do they want a global conflict?"

Putin said Ukrainian strikes on Russia with long-range weapons would need Western satellite, intelligence and military help - so the West would be directly involved. He said sending French troops to Ukraine would be a step towards a global conflict.

Speaking of NATO members in Europe, Putin said that small countries there "should be aware of what they are playing with", as they had small land areas and very dense populations.

A report from Kyiv quoted the Ukrainian air force as saying on the Telegram messaging app on Wednesday that they had shot down 13 of the 14 drones launched by Russia in an overnight attack on three regions.

Drone debris fell on energy infrastructure in Ukraine's northwestern region of Rivne, governor Oleksandr Koval said on Telegram.

The attack triggered a defence mechanism that cut power to some localities, although it has since been restored. Drone debris also damaged power lines in central Kirovohrad with repair work ongoing, its governor said.

The air force shot down 11 drones over the Mykolaiv region, with no details on damage reported by the local government.

Meanwhile, Sweden has announced \$1.3 billion military support for Ukraine. A report from Copenhagen said Sweden would send military aid worth as much as 13.3 billion Swedish crowns (\$1.3 billion) to Ukraine, its biggest package so far, to aid the war against Russia, the Nordic country's government said on Wednesday.

The package would help strengthen the Ukrainian air defence and included Saab's Airborne Surveillance and Control 890 aircraft.

N Korea dumps trash balloons across South

North Korea flew hundreds of trash-carrying balloons toward South Korea in one of its most bizarre provocations against its rival in years, prompting the South's military to mobilise chemical and explosive response teams to recover objects and debris in different parts of the country.

The ballooning campaign came as North Korean leader Kim Jong Un urged scientists to overcome a failed satellite launch and continue developing space-based reconnaissance capabilities, which he called crucial for countering US and South Korean military activities, state media said.

Kim also warned of unspecified "stern" action against South Korea over an exercise involving 20 fighter jets near the inter-Korean border hours before North Korea's failed launch on Monday.
