Grasim may pull the plug on Voda Idea investment

Mumbai, 9 September

Minority shareholders of Grasim Industries, who own 60 per cent stake in the company, are unlikely to agree for further investment in Vodafone Idea, say bankers.

This is because they have seen zero returns on their investments in the telecom company.

Last week, the operator agreed to raise up to ₹25,000 crore by issuing fresh equity and debt. However, with Grasim taking a ₹2,900-crore hit on its investment in the Vodafone Idea rights issue last year, bankers said the listed entity may not burn further cash in the venture.

The Birlas own 27.5 per cent stake in the operator. Of this, Grasim owns close to 11.5 per cent. "The shareholders of Grasim, which include top institutions, will ask why they should invest more money in a loss-making venture. With zero returns since the investment in the rights issue last year, Grasim's minority shareholders are not impressed," said the head of a fund house.

With Grasim withdrawing from any investment in Voda Idea, Aditya Birla (AB) Group will either have to invest through other firms or let its stake in the telecom firm fall, said bankers.

Before Covid-19 hit the Indian economy, Grasim had plans to invest ₹3,880 crore in FY21 as capital expenditure. However, with the government announcing a lockdown, capex for the entire year was scaled down.

An uptick in sales volume from May

reflected a month-on-month improvement in revenues and Ebitda (earnings before interest, tax, depreciation, and amortisation) across all its businesses.

Besides running its own businesses like viscose staple fibre or VSF, Grasim

also holds stake in key AB Group firms like Voda Idea, UltraTech, and Aditya Birla Capital. This attracts a holding company discount. As of Wednesday, Grasim had total market valuation of ₹45,000 crore, at ₹686 a share.

The fundraising by Voda Idea comes at a time when the firm is fighting a pitched battle with Reliance Jio and Bharti Airtel to retain market share.

It was hit hardest by the Supreme Court ruling in October last year, which required it to pay dues worth ₹58,254 crore to the government pertaining to adjusted gross revenues (AGR).

However, the apex court later gave 10 years to all telecom companies to pay their pending dues. Voda Idea has already paid ₹7,854 crore towards AGR dues to the telecom department.

Indiabulls rolls out QIP, sets floor price at ₹207 per share

New Delhi, 9 September

Indiabulls Housing Finance launched its QIP (qualified institutional placement) on Wednesday and set the floor price at ₹206.70 per equity share for the issue.

The Securities Issuance Committee of the company's board at a meeting held on September 9, 2020, approved the floor price, it said in a regulatory filing. "The company may offer a discount of not more than 5 per cent on the floor price so calculated for the issue (which opens on Wednesday)," it said.

In a separate filing, the company said the Securities Issuance Committee will have a meeting on September 14 to approve the issue price, including a discount, if any, for the equity shares to be allotted to the qualified institutional buyers.

At the company's extraordinary general meeting on July 29, it had sought shareholders' approval to raise up to ₹300 million by issuing securities through QIP or foreign currency convertible bonds.

Indiabulls Housing Finance stock settled at ₹201.15 on BSE, down 0.54 per cent from previous close.

Flipkart onboards 50,000 kiranas in festive push

Bangalore, 9 September

E-commerce giant Flipkart has significantly expanded its kirana onboarding programme to make deliveries to customers in more than 850 cities. It has done this in preparation for the festive season and its flagship sale event Big Billion Days.

With more than 50,000 kiranas onboarded, the Walmart-owned firm aims to provide a fast and personalised e-commerce experience to millions of consumers, while creating opportunities for digital upskilling as well as additional

income for kiranas.

The kirana programme has been further expanded to remote and faraway cities across the country, including places like Tinsukia, Agartala, and Kannur, making e-commerce more inclusive. "As one of the oldest retail formats in India, kiranas have one of the highest penetration and showcase effective management of the supply chain drivers, such as facilities, inventory, information, and sourcing, as well as in maintaining a longstanding relationship with consumers," said Amitesh Jha, senior vice-president, Ekart and Marketplace, Flipkart.



To help kiranas onboard and be active participants in the festive season, Flipkart's team

initiated contactless onboarding of kiranas through online application forms where kirana partners directly uploaded details along with required documentation. This enabled seamless onboarding without them having to step out during Covid-19 times.

Following a detailed verification check, the kirana partners were brought into the programme before they can deliver shipments. The team has also organised digital training on various tools, including app-based dashboards and digital payments, helping kiranas transform their business from tra-

ditional general trade stores to modern convenience stores.

Partnering sellers and micro, small and medium enterprises (MSMEs), Flipkart delivers millions of shipments every day through its robust supply chain across 100 per cent of the serviceable pincodes in India.

Flipkart is expanding its physical and digital infra, strengthening its supply chain capabilities while working with multiple ecosystem partners. These include freelance delivery executives and kiranas, thereby complementing their incomes and bringing more convenience to e-commerce consumers.

BPCL divestment is 'event risk' due to little info, says Fitch

Fitch Ratings on Wednesday said the privatisation of BPCL is an 'event risk' as there is little information about bidders and transaction structure.

The agency affirmed Bharat Petroleum Corporation's (BPCL) long-term foreign-currency issuer default rating at 'BBB'. The outlook is 'Negative'. "Fitch equalises BPCL's rating with that of its largest shareholder, the India sovereign (BBB-/Negative)... due to the strong likelihood of government support," it said.

The rating incorporates weak petroleum product demand and gross refining margins in the near-term, followed by a gradual recovery and strong marketing margins, reflecting

BPCL's ability to reap some benefits from low oil prices in its marketing segment, without a full cost pass-through to consumers.

However, the improvement is subject to risks of weak industry conditions persisting beyond baseline scenario, or capex or shareholder returns that are higher-than-expected.

"We continue to treat the potential divestment of BPCL by India as an event risk, as there is little information about bidders, valuation, and transaction structure, especially as BPCL owns assets across many verticals and bidders may not be interested in all of them," Fitch said.
