

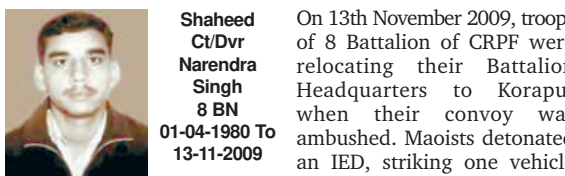

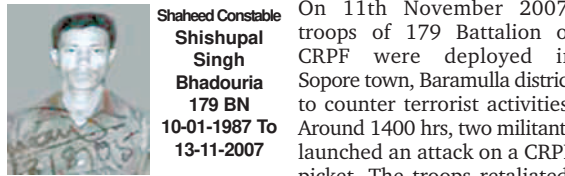

CENTRAL RESERVE POLICE FORCE 13 November 2009



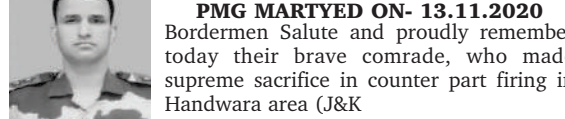

CENTRAL RESERVE POLICE FORCE 13 November 2007



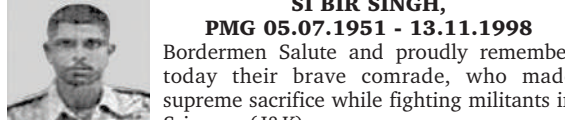

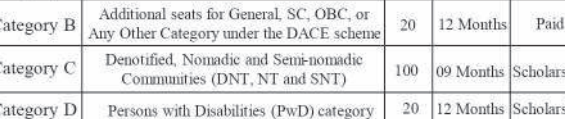
