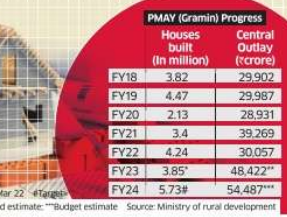

Expediting the Process

Rural development minister in talks with states to expedite the pace of house construction

At present, PMAY (G) in rural areas at 29.5m houses by March 2024

So far, 28.6m houses have been sanctioned, of which 22.1m have been built



New Delhi: The government is planning to advance its deadline for meeting the target under the Housing for All initiative for rural India by three months through October 2023, a senior official told ET.

Under the PMAY-G, the Centre is targeting the completion of 5.7 million houses to achieve the overall target, said the official.

The Centre has sharply raised its outlay for the PMAY-G in its revised estimate for FY23 to Rs 48,422 crore from the budget estimate of Rs 20,000 crore in a bid to give a fresh leg-up to the pace of house construction.

From Page 1. On the indirect tax side, the Finance Bill amended Section 109 of the Central Goods and Services Tax (CGST) Act to set up tribunals in a time-bound manner, which is expected to help address litigation issues related to GST.

THE CHANGES

- Provision for setting up GST Tribunal. WHAT IT MEANS: Helps address piling up of GST disputes. GST on goods imported under Bonded Warehouse Scheme. WHAT IT MEANS: Brings GST on domestically manufactured goods on par with imported ones under the scheme. Disputes below ₹50 lakh to go to a single-member bench. WHAT IT MEANS: Fast resolution of indirect tax disputes.

Outward remittances above ₹5 lakh. The budget had also proposed that the income received by real estate and infrastructure investment trust (REIT and InvIT) unitholders in the form of 'repayment of debt' will be taxed from April 1, 2023 onwards.
