The Company has availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting remote e-voting by the Shareholders of the Company.

The Shareholders of the Company holding shares as on the "cut-off" date i.e., Friday, November 18, 2022, were entitled to vote on the resolution(s) as set out in the Notice of the Postal ballot of Rail Vikas Nigam Limited (RVNL).



The voting period for remote e-voting commenced on Saturday, November 26, 2022 (09:00 Hours) and ended on Sunday, December 25, 2022 (17:00 Hours) IST and thereafter the NSDL e-voting platform was blocked. Votes cast through remote e-voting were then unblocked in the presence of following two witnesses not being in the employment of the Company. The confirmation in writing is attached as 'Annexure-A'.
