Companies which have a credit rating of "AA and above", where credit rating shall be of the unsupported bank borrowing or plain vanilla bonds of an entity, which have no structuring/ support built in; and in case, where an multiple rating agencies, highest of such rating shall be considered for the purpose of applicability of this framework
