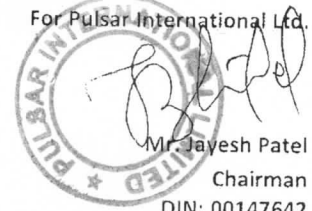

Review Report to The Board of Directors
