Pursuant to the receipt of the order passed by the Hon'ble National Company Law Tribunal, Kolkata bench on 30th November, 2021 (obtained on 27th December 2021) in relation to the scheme of amalgamation inter alia amongst Ricon Commerce Limited ("RCL"), with Adventz Finance Private Limited ("AFPL"), 1,50,200 shares of Chambal Fertilisers and Chemicals Limited held by RCL were vested into AFPL.

Zuari Global Limited has also provided the Non-Disposal Undertaking to Vistra ITCL (India) Ltd. (Debenture Trustee acting on behalf of Asia Pacific Pvt Credit Opportunities 1 Singapore Pte Ltd) vide disclosure dated 09.10.2020 with respect to 1,25,00,000 shares held in Chambal Fertilisers and Chemicals Limited.
