This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of PVR INOX Limited (the company), listed on your stock Exchange.


The Fund under its scheme has carried out sale of 52,115 shares of the Company on October 11, 2023. As a result, the shareholding of the Fund has decreased by 2% of the paid-up capital of the company as compared to previous disclosure on April 26, 2023 for 7.19%.
