
## Financial performance

- Revenue at Rs.4919 Cr, a growth of 17% (YoY), Growth upto Q3: 32%
- Achieved Break-even at PBT level for Q3/21-22, mainly contributed by focus on provision withdrawal and strict Budgetary control on expenses

#### **Business Environment**

- Domestic economy projected to grow by 9.2% in FY22 (Advance estimate, NSO)
- Downside risks to growth have risen with the renewed surge of COVID-19 infections, expected to impact the growth momentum in the last quarter of FY22
- Industrial activity (IIP index) recorded 19.9% growth (April-October 2021), as against a 17.3 per cent contraction registered during the corresponding period last year.
- Production Linked Incentive (PLI) schemes in critical sectors expected to provide the much needed push to capex
- India committed to reach carbon neutrality by 2070 during COP26
- Expected demand side policy interventions for green hydrogen to catalyze hydrogen growth
- Headwinds continue to be posed by global supply chain bottlenecks and commodity prices inflation

### **Operations**

Amid continued disruptions due to COVID in Q3FY22, focus on project deliveries led to:

- Commercial Operation Declaration (COD) achieved for Unit#8 of 2x660 MW Suratgarh TPS of RRVUNL, and Unit#4 of 4x250 MW Nabinagar TPS of BRBCL.
- Synchronization achieved for:
  - ✓ Unit#4 of 4x270 MW Bhadradri TPS at Manuguru of TSGENCO, 1x800MW of Dr Narla Tata Rao TPS at Vijayawada of APGENCO, 1x800 MW Sri Damodaram Sanjeevaia SDSTPS Stage-II, near Krishnapatnam of APPDCL, Unit#2 of 6X60 MW (R & M) Balimela Hydro Electric Project of OHPCL, near Bhubaneshwar
  - √ 10 MW Solar Photovoltaic Power Project of Singareni Collieries Company Limited (SSCL) at Ramagundam, and 22.5 MW (40 MW completed out of total 100 MW) of floating solar power plant at NTPC Ramagundam
- Full load achieved for 1x525 MW of Tuticorin Thermal Power Station Stage IV, and Unit#4 of 4x250 MW of Nabinagar Thermal Power Station of BRBCL
- First 3 Phase Mainline Electrical Multiple Unit (MEMU) having BHEL electrics rolled out from RCF, Kapurthala

#### Some of the Prominent orders received in Q3FY22 are:

- Maiden Order for 'Flexible operation study and implementation of study finding' from REGL Raigarh for 600 MW TPP. This will enable BHEL to demonstrate its capabilities for flexible operations of coal based power plants.
- Order for Flue gas Desulphurization (FGD) Package for 2x500 MW of NTPC Sipat TPP received during current quarter, taking total FGD orders received by BHEL from Indian Power Sector Utilities to about 32 GW
- Two international orders including 8 MWac Grid-connected Solar PV Project, Mauritius, and supply of AVR spares for Tuncbilek Thermal Power Plant, Turkey
- Supply & Services of 36 sets of IGBT based 2x500 kVA Hotel Load Converter for 3 Phase WAP-7 Electric Locos and 76 nos. of Traction Motor type 6FRA-6068 from CLW, Chittaranjan, and 104 nos. of Traction Motor type 6FRA from DMW, Patiala.
- Motor (VFD) driven Compressor package for coker unit and Wet Gas Compressor Pkg. from IOCL, Barauni, and Recycle Gas Compressor Pkg. at NRL Numaligarh from TOYO Engg. India Ltd.

#### **Atmanirbhar Bharat**

- 9000 HP Electric locomotives with BHEL electrics, successfully completed rating, performance and adhesion trials between Kharagpur Bhadrak section.
- Successfully manufactured and supplied, first time in India, environment friendly 1350 HP Diesel Electric Shunting Locomotive meeting US EPA (Environment Protection Agency) Tier-II standards
- Entered into a License Agreement for Upgraded Super Rapid Gun Mount (the main gun on Indian warships)
- Successful completion of design and engineering of a compact, modular design 420 kV hybrid gas insulated switchgear (HGIS)- placing the company in a position to offer 420 kV, 50/63 kA and 3150 / 4000 A HGIS with horizontally mounted single break circuit breaker design and cast aluminum alloy enclosure.
- Slurry Recirculation Prototype Pump developed in-house and successfully tested at BHEL's HPEP Hyderabad
   Unit. This pump has been designed to handle wet limestone-based slurry in FGD
- BHEL's BAP Ranipet Unit has been certified with AS9100 standards by M/s Novo Star Management Systems
  Solutions India Pvt. Ltd., with the scope of manufacturing and supply of Aerospace components, which is
  valid till November 2024.
