Gorbachev's death mourned as passing of rare leader

AP ■ BANGKOK
The passing of Mikhail Gorbachev, the last leader of the Soviet Union and for many the man who restored democracy to a then-communist ruled European nation, was mourned Wednesday as the loss of a rare leader who changed the world and for a time gave hope for peace among the superpowers.

AP ■ MOSCOW
Mikhail Gorbachev, who as the last leader of the Soviet Union waged a losing battle to salvage a crumbling empire that produced extraordinary reforms that led to the end of the Cold War, died Tuesday, he was 91.

The Central Clinical Hospital said in a statement that Gorbachev died after a long illness. No other details were given.

Kremlin spokesman Dmitry Peskov said in a statement that Russian President Vladimir Putin offered deep condolences over Gorbachev's death and would send an official telegram to Gorbachev's family in the morning.

विद्यमान की परिभाषा तथा फ्लोरिंग नीति को पंजीयन से अलग करके अलग आवंटन नीति में बदलाव किया है। इसी बदलाव के तहत प्राधिकरण ने सेक्टर-146 तथा 151 में गुप हाउसिंग को प्रत्यक्ष योजना निकाली है। गुप हाउसिंग को प्रत्यक्ष आवंटन के दौरान कॉन्ट्रिब्यूट के बदलाव को कन्सिडर स्टेटिंग के तहत सेक्टर लेते तक 100 फॉर्मों के अभाव में आवंटन रोकने की योजना है।
