In our opinion and to the best of our information and according to the explanations given to us, these standalone financial results:

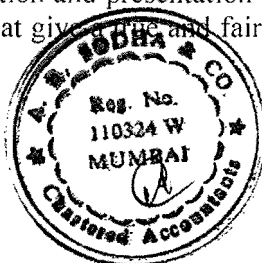
