- 1. I, Sameer Kishore Bhatnagar, Practicing Company Secretary (Membership No 30997, CP No 13115), was appointed as Scrutinizer by the Board of Directors of M/s Rathi Steel and Power Limited (the Company) in their meeting held on September 04, 2019 for the purpose of e-voting process on the agenda items to be transacted at the Annual General Meeting (AGM) of the Company held on October 30, 2019 at 10.00 A.M. at The Little Theatre Group, Copernicus Marg, New Delhi.

- 2.2 The e-voting period began at 10.00 AM on 27th October, 2019 and ended at 5:00 PM on 29th October, 2019. The votes received electronically from the Shareholders till Tuesday the 29th October, 2019 up to 5:00 pm, being the last date and time fixed by the Company for e-voting was considered for my scrutiny.
- 2.3 Particulars of all votes received electronically from the Members have been separately maintained for the purpose.
- 2.4 The votes received electronically were duly scrutinized and the shareholding was matched/confirmed with the Register of members of the Company as on the cutoff date i.e. October 23, 2019.
