Secretarial Compliance Report of M/s. Lambodhara Textiles Limited for the financial year ended 31st March 2023

We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **M/s. Lambodhara Textiles Limited** (CIN: L17111TZ1994PLC004929) (hereinafter referred as 'the listed entity'), having its Registered Office at 3A, B-Block, Pioneer Apartments, 1075-B, Avinashi Road, Coimbatore-641018. 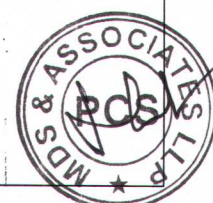
