पुलिस ने कांग्रेस विधायक के दामाद के खिलाफ गैर इरादतन हत्या का मामला दर्ज किया है। अधिकारियों ने बताया कि विधायक के दामाद के स्पोर्ट्स यूटिलिटी व्हीकल (एसयूवी) ने एक आटोरिक्शा व एक मोटरसाइकिल को टक्कर मार दी थी, जिसमें छह लोगों की मौत हो गई है। उन्होंने बताया कि दुर्घटना गुरुवार की शाम आणंद कस्बे को तारापुर से जोड़ने वाली सड़क पर स्थित सोजित्रा गांव के पास हुई। उन्होंने बताया कि हादसे में तीन महिलाओं सहित छह लोग मारे गए।

सोजित्रा थाने के पुलिस उपनिरीक्षक एपी परमार ने बताया कि आरोपी की पहचान सोजित्रा सीट से कांग्रेस विधायक पूनमभाई परमार के दामाद केतन पधियार के रूप में हुई है। दुर्घटना में केतन पधियार को भी चोट लगी थी और उसका आणंद के एक निजी अस्पताल में इलाज चल रहा है। उन्होंने बताया कि पधियार हिरासत में है और अस्पताल से छुट्टी मिलते ही उन्हें गिरफ्तार किया जाएगा। उनके खून का नमूना जांच के लिए भेजा गया है।
