

India supports BRICS expansion

Prime Minister Modi said on Wednesday that India will fully support the expansion of the BRICS. Modi was addressing the plenary session of the BRICS Business Forum leaders, where he said that India is trying to move forward with other countries on the motto "One Earth, One Family, One Future."

"India fully supports the expansion of BRICS membership moving forward with consensus," Modi said. Modi also

said at the open plenary session that BRICS stood for "Breaking Barriers, Revitalizing Economies, Inspiring Innovations, Creating Opportunities, and Shaping the Future".

Mr. Modi, Chinese President Xi Jinping, Brazilian President Luiz Inacio Lula da Silva, and South African President Cyril Ramaphosa attended the summit, while Russian President Vladimir Putin addressed the gathering through a pre-recorded video from Moscow.

"With the Russian

invasion of Ukraine, the sanctions imposed by the West, and the shift in geopolitical order, the potential significance of the bloc has increased, especially for Russia and China."

More than 40 nations, including Iran, Egypt, and Ethiopia, have expressed an interest in joining the forum. South Africa, Russia, and China support expanding the membership as they seek to increase their influence to counter the US.

Johannesburg, Aug 24: Prime Minister Narendra Modi on Wednesday called upon the BRICS nations to form "BRICS space exploration consortium which will focus on space research and weather monitoring. Addressing the plenary session of the 15th BRICS Summit here in South Africa, the Prime Minister said, "We are already working on the BRICS satellite constellation, but to move a step further, we should think about establishing a BRICS space exploration consortium."

He said to make BRICS a future-ready organisation, the respective societies also have to be made future-ready, and added that technology will play an essential role in the transformation.

"In the last two decades, BRICS has undertaken a long and magnificent journey and in this journey, the group has made numerous achievements," the Prime Minister said.

He also called on all BRICS countries to support the inclusion of the African Union in the G20.

"We welcome the move to give special importance to the countries of the global south in BRICS under the chairmanship of South Africa. India has also given importance to this subject under its G20 presidency," the PM said.

The Prime Minister pointed out that to give a new path to the BRICS agenda, India had put forth suggestions on issues such as railway research network, close cooperation between MSMEs, online BRICS database and startup firms.

He expressed happiness that a lot of progress was made on these issues.

Making an initial remark, at the open plenary session South African President Cyril Ramaphosa said BRICS nations need to advance the interests of the global south and called

upon the industrialised countries to honour their commitments to support climate actions through economic progress.

Earlier, Prime Minister Modi held a meeting with South African President Cyril Ramaphosa during which they reviewed the progress made in bilateral ties, exchanged views on regional and multilateral issues and also on ways to work jointly to strengthen the voice of the Global South.

"Had an excellent meeting with President @CyrilRamaphosa. We discussed a wide range of issues aimed at deepening India-South Africa relations-trade, defence and investment linkages featured prominently in our discussions. We will keep working together to strengthen the voice of the Global South as well," Modi said on X.

The Ministry of External Affairs (MEA) said, "Both leaders reviewed the progress made in bilateral relations between the

two countries and expressed satisfaction at the progress achieved in various fields including defence, agriculture, trade and investment, health, conservation and people-to-people ties."

Xi seeks improved global governance

Chinese President Xi Jinping on Wednesday urged BRICS countries to uphold fairness and justice, and improve global governance.

Xi, while addressing the 15th BRICS Summit, said strengthening global governance is the right choice if the international community intends to share development opportunities and tackle global challenges.

International rules must be written and upheld jointly by all countries based on the purposes and principles of the UN Charter, rather than dictated by those with the strongest muscles or the loudest voice, he said.

Xi also said ganging up to form exclusive groups and packaging their own rules as

international norms are even more unacceptable.

Focus on trade in local currencies

South Africa's BRICS sherpa told Sputnik on the sidelines of the bloc's summit in Johannesburg that the five emerging economies would focus on bolstering trade in their local currencies to gain greater independence from the dollar, rather than launching a common currency.

"The currency is being discussed but let me correct: It's not about a BRICS currency. It is too early to talk about a BRICS currency," Anil Sooklal said.

"What we are talking about is creating more financial inclusion in terms of global financial transactions, global financial trade and how we conduct our payment," he stated.

Brazil, India, Russia, China and South Africa will discuss "deepening interaction among ourselves using local currencies", the ambassador-at-large said.

President, PM, leaders congratulate ISRO team for successful deployment of Pragyan

Bengaluru, Aug 24: President Droupadi Murmu on Thursday congratulated ISRO team and fellow citizens for successful deployment of Pragyan-rover from inside Vikram-lander and said it marks the success of yet another stage of Chandrayaan-3.

"I look forward with excitement, alongside my fellow citizens and scientists to the information and analyses that Pragyan will acquire and enrich our understanding of the moon," Murmu said.

India had on Wednesday scripted history as ISRO's third Moon mission Chandrayaan-3's Lander Module (LM) touched down on the lunar surface, making it only the fourth country to accomplish the feat, and first to reach the uncharted south pole of Earth's only natural satellite.

Modi

Prime Minister Narendra Modi on Wednesday congratulated the country on the historic moment of Chandrayaan-3's landing on the moon.

This sounds the bugle for a developed India, said the prime minister, who joined through video

conference the scientists at ISRO to witness the soft landing of Chandrayaan-3.

"We are witness to the new flight of new India. New history has been written," he said.

Sonia Gandhi

Former Congress chief Sonia Gandhi on Thursday wrote to ISRO Chairman S Somanath over the success of Chandrayaan-3, saying the space agency's outstanding capabilities have been built up over decades and it being anchored on self-reliance since the early sixties has contributed to its great successes.

In her letter to Somanath, the Congress parliamentary party chief said she was writing to him to let him know how thrilled she was by the Indian Space Research Organisation's (ISRO) magnificent achievement on Wednesday evening.

"It is a matter of great pride and excitement to all Indians, particularly the younger generation," Gandhi said.

"ISRO's outstanding capabilities have been built up over decades. It has had remarkable leaders and a spirit of collective endeavour has

always driven it. Its being anchored on self-reliance since the early sixties has contributed to its great successes," Gandhi said in her letter.

Current meds effective for new COVID variants: US CDC

Washington, Aug 24: The US Centres for Disease Control and Prevention (CDC) said in a statement on Wednesday that it detected a new variant of the SARS-CoV-2 virus in the United States and in other countries and is

assessing the potential severity of the cases.

"CDC has detected a new SARS-CoV-2 variant labeled BA.2.86. CDC is continually monitoring for new variants and studying their potential impact on public health," the statement said.

The variant has "notable" genetic differences from previous versions of the SARS-CoV-2 virus, the statement said. However, existing tests and medications for COVID-19 appear to be effective with the variant, the statement said.
