Dear Sir/ Ma'am,

In terms of Regulation 33(3) of the SEBI (LODR) Regulations, 2015, **Metalyst Forgings Limited** (the "Company") is obliged to submit and/or publish the financial results for the quarter and year ended March 31, 2021 on or before May 30, 2021. However, due to ongoing second wave of the CoVID-19 pandemic and restrictions and lockdown imposed by various state governments the SEBI vide its Circular No. **SEBI/HO/CFD/CMD1/P/CIR/2021/556 dated April 29, 2021** have provided relaxations with certain provisions of SEBI (LODR) Regulations, 2015 and, accordingly, the due date for submission of the financial results for the quarter and year ended March 31, 2021 has extended till June 30, 2021.
