In this connection company submitted its reply saying "please note Mr. H.P. Sharma's date of Birth is 27.10.1946, so he will attain 75 years on 27.10.2021 and accordingly, we have Annual general meeting scheduled on 10.08.2021 where we have taken special resolution for Mr. H.P. Sharma for attaining 75 years for approval before the shareholders, So we are within the time limit for passing of special resolution for Mr. H.P. Sharma under the SEBI LODR Regulation."

There after there is no further correspondence as regards the said point.
