## Brief Profile of Shri Pankaj Kumar, IAS, Chief Secretary, Government of Gujarat

Shri Pankaj Kumar, a 1986-batch IAS officer, took charge as the new Chief Secretary of Gujarat with effective from 01st September, 2021. He is a civil engineer from IIT - Kanpur. He had successfully spearheaded relief and rehabilitation work during the floods in 2017 and during cyclone Vayu in 2019.

He has also served in departments including revenue, home, health & family welfare in various capacities. He also led the state administration in adopting digital governance after the Centre started promoting the Digital India movement.

After the Covid-19 pandemic outbreak last year, he was given the direct responsibility of the health & family welfare department where he reportedly played a key role in quickly upgrading health infrastructure of the state to meet the pandemic challenge.
