We refer to your E-mail message dated 22/02/2021 wherein we have been informed that, the company is non- compliant with Regulations 6 (1) of SEBI (LODR) Regulations 2015, and advised to the Company to ensure Compliance with the above Regulations and ensure to pay the Fine amount of Rs. 108560/- imposed by the exchange for the said Non-Compliance. In this connection we would like to put forth the following facts for your consideration.

- 1. The erstwhile qualified Company Secretary Mr. Maxim Joseph suddenly passed away on 24-12-2019, the communication of which was informed to Stock Exchange on 27-12-2019.
- 2. Subsequently, the Company has issued a paper advertisement in Trinity Mirror & Makkal Kural 9-1-2020 calling for from the qualified person for the post of Company Secretary. We are attaching herewith said papers advertisement for your perusal. The company has not yet received any response for the advertisement.
- 3. The Company has also duly informed the Stock Exchange that Mr.Manoj Kumar Tibrewal, Managing Director will also function as the Compliance Officer till a new Company Secretary is appointed vide our letter dated 20-1-2020 and the same has been acknowledged by the Stock Exchange We are enclosing herewith the copy of our Letter and the Acknowledgement for your reference.

- 4.As you are aware that in view of pandemic Covid-19, the State Government has announced lock down since 25-3-2020 and our office is working with very limited staffs for emergency work only. Once this pandemic situation is eased out, the Company would issue a fresh Advertisement in the Newspaper calling for the qualified company secretary.
- 5. Above all, the company is not in operation since 2015 consequent to the sale of entire assets of the company by the Lenders towards repayment of loan and therefore there is no source of Income/ Revenue to the Company. Consequently the company has become financially sick. The Company is functioning only with very few staffs just to comply with Listing and other Statutory formalities and the expenses pertaining to the above are being met out by the Managing Director himself personally.
- 6.Under these circumstances, we request you not to take any further action in respect of the appointment of qualified Company Secretary till the pandemic situation is eased out. Once the return of normalcy in the Country as far as the pandemic Covid-19 is concerned, the Company would take further action in this regard. On such situation, the company would duly inform the Stock Exchange about the course of action taken.
- 7. Since the Company is financially sick, the Company is not in a position to pay the Fine amount of Rs. 108560/- as informed by your E- mail message dated 22/0.2021.

We therefore request you to kindly waive the said fine of Rs. 108560/-

We would request to consider the facts stated above and defer further proceedings in this regard.

Chennai, Jan 9: School education, vouth welfare and sports minister Sengottaiyan said the government would consider reviving yoga in corporation-run schools, hospitals and public spaces in Chennai.

Sengottaiyan was responding to former Chennai Corporation mayor M Subramanian of the DMK, who recalled the previous DMK-led corporation's emphasis on yoga. He said yoga platforms were set up in 38 public parks, and corporation staff, elected councillors, pregnant mothers and students of 138 schools were encouraged to do yoga with the support of 100 trained staff. But, the programme fizzled out after the change of guard, he said. "Yoga is the only way to live without stress, to live in good health and to look good. Even anger can be managed with yoga. Yoga is important to keep the body healthy," the minister said, assuring that discussions would be held with the municipal administration to revive
