### AWARD

- The Plaintiffs herein filed the suit for declaration that the plaintiffs are the legal heirs of Mohamed Ibrahim Maricar S/o Zaccaria Maricar, who died at Karaikal on 03-10-2020.
- At the request of both the parties the suit in O.S. No.11/2021 on the file of
   Principal District Munsif Court was referred to this Lok Adalat under
   Section 19 of the Legal Services Authorities Act (Act 39/1987).
- 3. This is a suit for declaration of legal heir. Both parties present. Defendant has accepted the claim of the plaintiffs. Suit documents have been perused and satisfied. Further as per court order paper publication was effected and no rival claim recorded. Hence the settlement by the parties has been recorded by the Lok Adalat.
- Therefore, as per the settlement arrived between the parties before this Lok Adalat, it is declared that the plaintiffs are the legal heirs of Mohamed Ibrahim Maricar S/o Zaccaria Maricar, who died at Karaikal on 03-10-2020.

5. The Award Passed by this Lok Adalat shall be deemed to be a decree of the Civil Court as per Section 21 of the Legal Services Authorities Act 1987.
