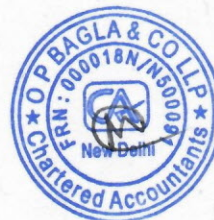


- 1 The above financial statements have been reviewed by the Audit Committee in its meeting held on 11th February, 2019 and then approved by the Board of Directors in its meeting held on 11th February, 2019.
- 2 With effect from 1st April, 2018, the Company has adopted Ind AS-115 'Revenue from Contracts with Customers'. The application of Ind AS-115 did not have any material impact on the financial results of the Company.
- 3 Consequent to the introduction of Goods and Service Tax (GST) with effect from 1st July, 2017, Central excise, Value Added Tax (VAT) etc. have been subsumed into GST. In accordance with Ind AS-115 on 'Revenue' and Schedule III of Companies Act, 2013, unlike Excise duties, levies like GST, VAT etc. are not part of Revenue. Accordingly, the figures for the period nine months ended 31st December, 2017 and year ended 31st March, 2018 are not strictly comparable to those thereafter. The following additional information is being provided to facilitate such understanding:
