The Company has paid the fine to BSE Ltd. on 17th May, 2019.

The Company has paid the fine  $\overline{\delta f}$  Rs. 92,000/-+18% GST on  $07^{th}$  March, 2019.

The Company has also paid the fine of Rs. 37,000/- + 18% GST on 17th May, 2019.
