## भारत में कोरोना के 547 नए मामले

नई दिल्ली। भारत में कोविड-19 के 547 नए मामले सामने आने के साथ ही देश में अभी तक कोरोना वायरस से संक्रमित हुए व्यक्तियों की संख्या बढ़कर 4,46,66,924 हो गयी।

भारत में अप्रैल 2022 के बाद पहली बार कोविड-19 के दैनिक मामले एक हजार से कम दर्ज किए गए हैं। केन्द्रीय स्वास्थ्य मंत्रालय द्वारा सोमवार सुबह आठ बजे तक जारी अद्यतन आंकड़ों के अनुसार, संक्रमण के कारण महाराष्ट्र में एक मरीज की मौत होने से मृतक संख्या बढ़कर 5,30,532 हो गयी है। वहीं, उपचाराधीन मरीजों की संख्या घटकर 9,468 रह गयी है। अप्रैल 2020 से पहली बार उपचाराधीन मरीजों की संख्या में

10 हजार तक की कमी आई है। आठ अप्रैल 2020 को देश में कोविड-19 के 540 मामले सामने आये थे। आंकड़ों के अनुसार, उपचाराधीन मरीजों की संख्या संक्रमण के कुल मामलों का 0.02 प्रतिशत है, जबकि कोविड-19 से उबरने की दर बढ़कर 98.79 प्रतिशत हो गयी है। बीते 24 घंटों में कोविड-19 का इलाज करा रहे मरीजों की संख्या में 2,839 की कमी दर्ज की गयी है।

इस बीमारी से उबरने वाले मरीजों की संख्या बढ़कर 4,41,26,924 हो गयी है जबकि मृत्यु दर 1.19 प्रतिशत है। देशव्यापी कोविड-19 रोधी टीकाकरण अभियान के तहत अभी तक 219.80 करोड़ खुराकें दी जा चुकी हैं। गौरतलब है कि

भारत में सात अगस्त 2020 को कोरोना वायरस संक्रमितों की संख्या 20 लाख, 23 अगस्त 2020 को 30 लाख और पांच सितंबर 2020 को 40 लाख से अधिक हो गई थी। संक्रमण के कुल मामले 16 सितंबर 2020 को 50 लाख, 28 सितंबर 2020 को 60 लाख, 11 अक्टूबर 2020 को 70 लाख, 29 अक्टूबर 2020 को 80 लाख और 20 नवंबर को 90 लाख के पार चले गए थे। देश में 19 दिसंबर 2020 को ये मामले एक करोड़ से अधिक हो गए थे। पिछले साल चार मई को संक्रमितों की संख्या दो करोड़ और 23 जून 2021 को तीन करोड़ के पार पहुंच गई थी। इस साल 25 जनवरी को संक्रमण के कुल मामले चार करोड़ के पार हो गए थे।

पाटन और सांसद नीरज डांगी को मेहसाणा लोकसभा क्षेत्र का पर्यवेक्षक बनाया गया है। पार्टी के वरिष्ठ नेता शकील अहमद खान, कांतिलाल भुरिया, राजेश लिलोटिया और कुछ अन्य नेताओं को भी अन्य क्षेत्रों के पर्यवेक्षक की जिम्मेदारी सौंपी गई है।
