This additional disclosure is with reference to the disclosures made by certain members of the Blackstone Sponsor Group listed below (collectively, the "Pledgors") to Embassy Office Parks Management Services Private Limited (the "REIT Manager") on June 24, 2019, in relation to the creation of a pledge of, in aggregate, 331,991,780 units (collectively, the "Relevant Units") of Embassy Office Parks REIT (the "REIT") (copy enclosed as "Annexure A").

As on the date of this letter, the Blackstone Sponsor together with the Blackstone Sponsor Group own, in aggregate, 426,763,588 units of the REIT that constitute approximately 55.30% of the total outstanding units of the REIT.

The Relevant Units which have been pledged by the Pledgors, as previously disclosed to the REIT Manager, constitute 43.02% of the total outstanding units of the REIT, i.e. more than 50% of the total units owned by the sponsor groups and more than 20% of the total outstanding units of the REIT, in each case, as on the date of this letter.

The Relevant Units and the shares of the Pledgors have been pledged in favour of Deutsche Bank AG, Mumbai Branch and Deutsche Bank AG, Singapore Branch, in its capacity as the "Onshore Security Agent" and the "Offshore Security Agent", respectively, in relation to a credit facility availed by I-REIT ML (NQ) LTD (the "Borrower") from specific overseas banks (the "Lenders") pursuant to, and as required under the terms of, the facility agreement dated June 24, 2019 executed between the Borrower, the Pledgors, the Security Agent, the Offshore Security Agent and the Lenders (the "Facility Agreement"). As previously disclosed, the pledge was created on June 24, 2019.

The Onshore Security Agent is a scheduled commercial bank, and the pledge has been created in its favour in its capacity as the security agent acting for and on behalf of the Lenders or persons who are the lenders under the Facility Agreement from time to time.

The aggregate value of the Relevant Units as on the date of creation of the pledge was INR 123,921,110,956.77 ("Amount A") and the credit facility made available to the Borrower was USD 600,000,000.00, which amounts to INR 41,687,280,000.00 ("Amount B"), using the USD/INR exchange rate prevailing on the date of creation of the pledge. The security cover ratio (i.e. Amount A / Amount B) as on the date of creation of the pledge was 2.97 times.

In accordance with the terms of the Facility Agreement, the amounts borrowed by the Borrower under the Facility Agreement are to be utilized for genuine business purposes of the Pledgors outside India and not for any investments, either directly or indirectly, in India. The amounts borrowed would not be made available, directly or indirectly, to the REIT.
