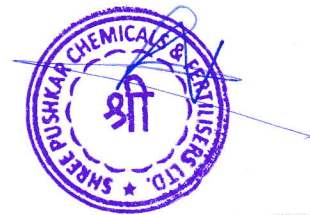

Further, the Company has received confirmation from Mrs. Ranjana Makharia, that there are no material reasons for her resignation other than those mentioned in her resignation letter.



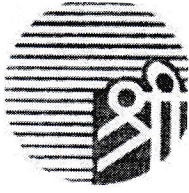

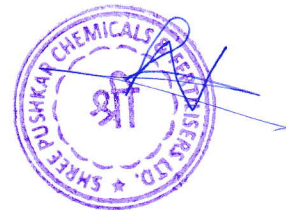
