In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, please find enclosed a copy of the Postal Ballot Notice dated March 03, 2022 (the “Notice”) together with Explanatory Statement, seeking approval of the Members by passing the ordinary resolution in respect of appointment of Shri Mirza Mohammad Abdulla (DIN- 09388832) as Director (Production & Planning) of the Company, as set out in the Notice.

Pursuant to Section 110 of the Companies Act, 2013 (the “Act”), read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, (including any statutory modification(s) or re-enactment thereof, for the time being in force) (the “Rules”) and General Circulars No. 14/2020 dated 8 April 2020, 17/2020 dated 13 April 2020, 22/2020 dated 15 June 2020, 33/2020 dated 28 September 2020, 39/2020 dated 31 December 2020 and 10/2021 dated June 23, 2021 and 20/2021 dated 08 December, 2021 issued by the Ministry of Corporate Affairs (the “MCA Circulars”), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable laws and regulations, the Company has sent the Postal Ballot Notice on Thursday, March 03, 2022, to all those Members whose names appear in the Register of Members as on the cut-off date i.e. Saturday, February 26, 2022 and who have registered their e-mail address with Company (in respect of shares held in physical form) and/or with their Depository Participants (in respect of shares held in dematerialized form) and made available to the Company by the respective Depositories. In terms of MCA Circulars, the communication of the assent or dissent of the members would take place only through the remote e-voting system.

The Company has engaged the services of “National Securities Depositories Limited” (“NSDL”) for providing remote e-voting facility to all its Members. The cut-off date for entitlement of voting is Saturday, February 26, 2022. The remote e-voting will commence on Friday, March 04, 2022 (9.00 a.m. IST) and shall end on Saturday, April 02, 2022 (5.00 p.m. IST). The results of postal ballot will be declared on or before Monday, April 04, 2022.

Notice is hereby given, pursuant to Section 110 of the Companies Act, 2013 (the “**Companies Act**”), and other applicable provisions, if any, of the Companies Act, Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 (the “**Management Rules**”), read with the General Circular Nos. 14/2020 dated 8 April 2020, 17/2020 dated 13 April 2020, 22/2020 dated 15 June 2020, 33/2020 dated 28 September 2020, 39/2020 dated 31 December 2020 and 10/2021 dated June 23, 2021 and 20/2021 dated 08 December, 2021, issued by the Ministry of Corporate Affairs (“**MCA**”) (hereinafter collectively referred to as “**MCA Circulars**”), that the resolution appended below for seeking approval for appointment of Shri Mirza Mohammad Abdulla (DIN- 09388832) as Director (Production & Planning), is proposed to be passed as an ordinary resolution by the Members of MOIL Limited (“**Company**”) through Postal Ballot by voting through electronic means (“**remote e-voting**”).

In compliance with the aforesaid MCA Circulars, this postal ballot notice (“**Notice**” / “**Postal Ballot Notice**”) is being sent only through electronic mode to those Members whose e-mail addresses are registered with the Company/Depositories and the communication of assent/ dissent of the Members on the resolution will only take place through the remote e-voting system. If your e-mail address is not registered with the Company/Depositories, please follow the process provided in the notes to receive this Postal Ballot and login ID and password for remote e-voting. .

An explanatory statement pursuant to Sections 102 and 110 of the Companies Act and other applicable legal provisions of the Companies Act pertaining to the said Resolution setting out the material facts and the reasons thereof, are also appended hereto for your consideration.

Pursuant to Rule 22(5) of the Management Rules, the Company has appointed Shri CS Bhojraj Wakodikar a Practicing Company Secretary (C.P. No. 8509) as the scrutinizer (the “**Scrutinizer**”) to conduct the Postal Ballot voting through remote e-voting process in a fair and transparent manner.

The remote e-voting period commences from 9.00 a.m. (IST) on **Friday, 4th March, 2022 and ends at 5.00 p.m. (IST) on Saturday, 02nd April, 2022**. In accordance with the MCA Circulars, members can vote only through the remote e-voting process. Accordingly, the Company is pleased to provide remote e-voting facility to all its members to cast their votes electronically. Members are requested to read the instructions in the Notes in this Postal Ballot Notice so as to cast their vote electronically **not later than 5:00 p.m. IST on Saturday, 02nd April, 2022 (the last day to cast vote electronically)** to be eligible for being considered, failing which it will be strictly considered that no vote has been received from the shareholders

The Scrutinizer shall after conclusion of the voting through remote e-voting unblock the votes cast through remote e-voting. The Scrutinizer will submit his report to the Chairman of the Company, or any person authorized by him upon completion of the scrutiny of the votes cast through remote e-voting. The results

2. In accordance with the MCA Circulars, this Postal Ballot Notice is being sent only by electronic mode to those members whose names appear on the Register of Members / List of Beneficial Owners as on **Saturday, 26th February, 2022 (“Cut-off Date”)** received from the Depositories and email address registered with the Company/Depositories. EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013 FORMING PART OF THE NOTICE

The President of India acting through Ministry of Steel vide Order No. 4/1/2020-BLA dated 10.01.2022 has appointed Shri Mirza Mohammad Abdulla as Director (Production & Planning) on the Board of the Company from the date of his assumption of charge of the post, till the date of his superannuation i.e. 31.08.2026, or until further orders, whichever is earlier. Accordingly, Board of Directors took on record his appointment vide CIRCULAR-RESOLUTION No.12 of 2021-22 dated 10.01.2022. Shri Mirza Mohammad Abdulla has assumed the charge as Director (Production & Planning) w.e.f. 10.01.2022.

As per Regulation 17 (1C) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the listed entity shall ensure that approval of shareholders for appointment of a person on the Board of Directors is taken at the next general meeting or within a time period of three months from the date of appointment, whichever is earlier.

In view of provisions of Regulation 17 (1C), the company has to take approval of shareholders on or before 09.04.2022 (i.e. within a time period of three months from the date of appointment) for appointment of Shri Mirza Mohammad Abdulla.

Pursuant to Section 152 of the Companies Act, 2013, Shri Mirza Mohammad Abdulla has given consent to act as Directors of the Company, and have also given requisite Notices/disclosures pursuant to provision of the Companies Act 203. He also possesses appropriate skills, expertise and competencies in the context of the Company's businesses.

Shri Mirza Mohammad Abdulla and his relatives are interested in this Resolution. None of the Directors and Key Managerial Personnel of the Company, their relatives, is in any way, concerned or interested, financially or otherwise, in the resolution set out for this item in the Notice.
