પીટીઆઈ જયપુર, તા.૧૭ અદાણી-હિંડનબર્ગ વિવાદ પર વડાપ્રધાન નરેન્દ્ર મોદી પર નિશાન સાધતા કોંગ્રેસે શુક્રવારે પ્રશ્ન પછથો હતો કે, તેઓ અદાણી ગ્રૂપ સામેના છેતરપિંડીના આરોપોની સંયુક્ત સંસદીય સમિતિ (જેપીસી) તપાસના આદેશથી શા માટે ડરે છે અને તેઓ કોને બચાવવાનો પ્રયાસ કરી રહ્યા છે. અદાણી ગ્રૂપને કારણે નાના રોકાણકારોને રૂપિયા ૧૦.૫ લાખ કરોડ ગુમાવવાનો વારો આવ્યો છે, જ્યારે સિક્યુરિટીઝ એન્ડ એક્સચેન્જ બોર્ડ ઓફ ઇન્ડિયા અને રિઝર્વ બેન્ક ઓફ

ઈન્ડિયા હાલ શાંત છે, તેમ કોંગ્રેસના રાષ્ટ્રીય પ્રવક્તા ગૌરવ વહાભે પત્રકાર પરિષદમાં જણાવ્યું હતું. કોંગ્રેસ શ્રેણી હમ અદાણી કે હે કોનના (અમે અદાણી સાથે કેવી રીતે સંબંધિત છીએ) ભાગરૂપે તેઓ અહિં આવ્યા હતાં. અમેરિકા સ્થિત એક્ટિવિસ્ટ શોટ-સેલર હિંડનબર્ગ રિસર્ચ દ્વારા ગૌતમ અદાણીની આગેવાની હેઠળના ગ્રૂપ સામે ૨૪ જાન્યુઆરીએ બહાર પાડવામાં આવેલ અહેવાલમાં છેતરપિંડીબર્થા વ્યવહારો અને શેરના ભાવમાં હેરાફેરી સહિતના આક્ષેપો કર્યા બાદ અદાણી ગ્રૂપના
