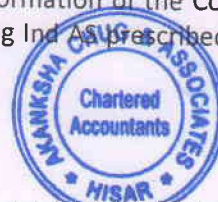
Basis for Opinion

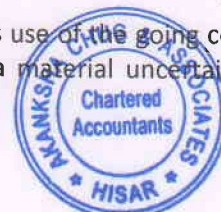
The Board of Directors is also responsible for overseeing the Company's financial reporting process.
