# Odd-Even scheme half-baked, says SC

NIMISH KUMAR New Delhi

The Supreme Court Friday said the Odd-Even traffic regulation may not be a permanent solution, especially when the Central Pollution Control Board (CPCB) says cars contribute only 3 per cent to the pollution levels.

Garbage dumping, construction waste and road dust are major contributors to pollution levels. The top court asked Delhi government to clear whether there has been any relief from air pollution from the Odd-Even scheme.

As Delhi-NCR continued to battle air pollution, AQI hovered around 482 in the capital on Friday. The CPCB told the SC that cars are contributing 3 per cent to pollution levels and all the vehicles combined contributing 28 per cent. Senior advocate for Delhi govt Mukul Rohatgi told the court that it may help if certain exemptions (like two-wheelers) under the scheme are removed. But if two-wheelers are not allowed, the city will come to a standstill.

The Delhi government mentioned that pollution levels get reduced by 5-15 per cent due to the

As many as 24 MPs from various parties did not attend the meeting, but the absence of Gambhir, the lone BJP leader from Delhi in the committee, snowballed into a political row as the AAP hit out at the saffron party over the issue and questioned its seriousness in tackling the cri-

As many as 24 parliamentarians from various parties, including the ruling Bharatiya Janata Party (BJP) and the Congress, did not attend the meeting.

The MPs who attended the meeting were AAP's Rajya Sabha MP Sanjay Singh, BJP's Jagdambika Pal who heads the panel, CR Patil of the saffron party and Hasnain Masoodi of the National Conference.

According to sources, the members of the panel who attended the meeting were extremely upset with the absence of the environment secretary, the DDA chairman and officials of the three municipal corporations of the national capital and planning to raise the issue with the Lok Sabha Speaker.

## Food on trains will TENSION ALONG LAC HAS REDUCED, SAYS RAJNATH now cost you more

**OUR BUREAU** / New Delhi

The Railway Ministry on Friday announced upgradation of food menu on trains, revising tariff of the catering services, promising better quality, hygiene and variety.

The new catering tariff comes in force with immediate effect in the mail and express trains while it will be effected in Rajdhani, Shatabdi and Duronto trains where the tariff is collected prepaid with the fare only from 29.03.2020. It will cost 3% to 9% more to passengers opting for meals on the prepaid

trains. The Janata meal kept unchanged at Rs 20. No more ala-carte meals permitted for sale in view of complaints of overcharging as only snacks like samosa, pakoda, etc will be allowed.

Snack meal with regional cuisine/flavour is being introduced at Rs 50. This would be of 350 grams and the menu will be decided by IRCTC.

Biryani to be offered in three varieties as a standard

meal in view of popularity with veg, egg and chicken varieties costing Rs 80, Rs 90 and Rs 110 respectively. The railway also introduced

chicken curry as an option in standard non-veg meal in addition to the existing standard non-veg meal with egg curry and standard veg meal.

The veg breakfast will costs Rs 40 and non-veg breakfast Rs 50. The standard veg meal will be available at Rs 80, standard non-veg meal with two eggs in curry at Rs 90 and non-veg meal with chicken curry Rs 130.

In case of the Rajdhani, Duronto and Shatabdi, there will be higher tariff for 1AC where morning tea will cost Rs 35, breakfast Rs 140, lunch/dinner Rs 240 and evening tea Rs 140. In the sleeper class in

Duronto trains, these will be still lower as morning tea will cost Rs 15, breakfast Rs 65, lunch/dinner Rs 120 and evening tea Rs 50. The last revision in the tariff

of food was made in 2013 in Rajdhani, Shatabdi and Duronto trains and in 2012 in other mail and express trains.



## Survey: 3 in 5 journos face work-related threats

AGENCIES / New Delhi

About three in five journalists in India receive threats or pressure at some point of time, mostly through social media platforms like Facebook, Twitter as well as private messaging app like WhatsApp, said a survey on Friday.

Of those who faced threats/harassment, 35 per cent believe that they were targeted because of the angle or the way a story was reported by them.

While 29 per cent of the overall respondents disclosed that they received threats once in a year, 19 per cent of the respondents received threats several times a month, showed the results Vision Foundation in association with the National Union of Journalists (India). Out of those who were threatened, around 46 per cent respondents claimed

that social media platforms like Twitter or Facebook were the medium, followed by 17 per cent respondents who were threatened via private messaging apps like WhatsApp/Message.

On the other hand, 76 per cent journalists said that either no safety protocol existed in their organisations or that they were not trained for safety issues.

At least four journalists were killed in India in 2019 due to work-related issues. The "Threats to Safety of

Journalists in India" survey involved 823 media professionals, out of which approximately 21% were female. The results suggest that journalists face physical,

psychological and emotionof the survey conducted by all risks because of many factors like division of ideology among citizens, high voltage political situations, impunity for crime against journalists and ethical dimensions of journalism.
