**SUB.: OUTCOME OF BOARD MEETING HELD ON NOVEMBER 09, 2022.**

**1) ALLOTMENT OF SHARES PURSUANT TO THE SCHEME OF ARRANGEMENT**

With reference to the captioned subject, this is to inform you that, the Board of Directors of the Company has, at its meeting held today i.e. November 09, 2022, in terms of Clause 13 of the Scheme of Arrangement providing for amalgamation of Gopi Synthetics Private Limited (“GSPL”), Aarnav Synthetics Private Limited (“ASPL”), Aarnav Textile Mills Private Limited (“ATMPL”), Symbolic Finance and Investment Private Limited (“SFIPL”) and Ankush Motor and General Finance Company Private Limited (“AMGFCPL”) with Aarnav Fashions Limited (“AFL”) and their respective Shareholders and Creditors (“Scheme of Arrangement”), issued and allotted 2,72,33,628 fully paid up Equity Shares of Rs. 10/- each to the shareholders of GSPL, ASPL, ATMPL, SFIPL and AMGFCPL (“Transferor Companies”) whose names appeared in register of members of the Transferor Companies as on November 05, 2022 (“Record Date”) in the ratio of 56 fully paid up Equity Shares of our Company for every 100 equity shares and 100 Type B-DVR Equity Shares held in the GSPL, 58 fully paid up Equity Shares of our Company for every 100 Equity Shares held in ASPL, 136 full paid up Equity Shares of our Company for every 100 equity shares and 100 Type B-DVR Equity Shares held in the ATMPL, 363 fully paid up Equity Shares of our Company for every 100 Equity Shares held in SFIPL and 3,834 fully paid up Equity Shares of our Company for every 100 Equity Shares held in AMGFCPL on the Record Date.

The details of the allottees is annexed herewith marked as **Annexure – A**.

Further, in terms of Clause 15.4 of the Scheme of Arrangement, inter-company balances, amounts or investments, if any, between the Transferor Companies and the Transferee Company, appearing in the books of accounts of the Transferee Company and respective Transferor Companies, if any, shall stand cancelled without any further act or deed upon the Scheme coming into effect.
