**Reg.: Disclosure under Regulation 30 of Securities Exchange Board of India (LODR) Regulations, 2015: Reporting of Borrowal Fraud of Bank's Exposure in M/s Dewan Housing Finance Corporation Limited (DHFL) involving a total amount of Rs.815.44 crore**

Pursuant to the applicable provisions of SEBI (LODR) Regulations and the materiality policy of the Bank we inform as under:

In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and having regard to the Bank's policy on determination and disclosures of material events, it is informed that an NPA Account, viz. M/s Dewan Housing Finance Corporation Limited (DHFL) with outstanding dues of Rs.815.44 crore has been declared as fraud and reported to RBI as per regulatory requirement. Further, Bank has already made provision of Rs.203.86 crore as per the prescribed prudential norms.

We request you to take note of the above.
