Pursuant of Regulation 30, 51 and other applicable regulations of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with corresponding circulars and notifications issued thereunder, we hereby inform that the Company has received an e-mail dated 03 October 2023 from BSE Limited with respect to imposition of fine of Rs. 31,000 (Rupees Thirty-One Thousand) for non-submission of utilization of issue proceeds under Regulation 52(7) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"). However, in our case there was no deviation in the utilization of issue proceeds and the issue proceeds have been fully utilized. Even though, the Company was trying to submit the statement about 'no deviation in utilization of issue proceeds' but there was no specific tab available for such submission on the portal of the exchange. However, upon receipt of exchange's first communication about non-submission statement of utilization of issue proceeds and we have been communicated that the statement of utilization of issue proceeds shall be submitted only under the aforesaid tab i.e. "Statement of Material Deviation in proceeds of issue of NCD/NCRP" even though there is no deviation in the utilization of issue proceeds. Accordingly, the Company has submitted the disclosure under Regulation 52(7) dated 04 August 2023 on 15 September 2023.
