

The meeting commenced at 10:00 AM (IST) and concluded at around 10:15 AM (IST).

Mr. Murugavel J occupied the Chair. He welcomed the shareholders for the meeting. He then called the meeting to order after ascertaining the quorum.

He introduced the Directors and Key Managerial Personnel who had attended the meeting. The Chairman also informed presence of representatives of Statutory Auditors Mr. K Raghuram, M/s B.S.R & Co LLP, Chartered Accountants and Secretarial Auditor Mr. V. Suresh.

With the permission of the members, notice of the meeting was taken as read.

The Chairman informed the shareholders that the Auditors' Report on the accounts for the year ended 31st March 2023, being an unqualified one (clean report), was not required to be read out at the Annual General Meeting as per the provisions of Section 145 of the Companies Act, 2013. With the permission of the members, Auditors report was taken as read.

He informed the members that a certificate had been obtained from the practising company secretary regarding compliance with SEBI (Share Based Employee Benefits) Regulations, 2014. He further informed that the certificate and the Registers are available for inspection through email sent to the Company.

The Chairman then delivered his speech. After the speech, he requested the members to seek clarifications if any on the audited accounts and on all other subjects, as well as set out in the notice. He further informed the members that he is interested on the ITEM NO.4 of the notice of meeting and hence Mr. Milind S. Sarwate, Chairman of Nomination and Remuneration Committee will provide clarifications if any on the above items.

The Chairman then requested the members to seek clarifications if any only on the matters set out in the notice and to take a maximum of 3 minutes each to provide equal opportunity to participate in the discussion. He further requested the members to avoid raising the same question raised by other members and informed them that he will respond to the queries collectively at the end. Three members have registered as speakers. The queries raised by a shareholder through email was answered though he did not turn up as a speaker.

The following items of business, as per the Notice of AGM dated May 09, 2023, were transacted at the meeting.

1. Adoption of Standalone Financial Statements of the Company for the financial year ended March 31, 2023 and the reports of the Board of Directors ('the Board') and Auditors thereon.
2. Adoption of consolidated financial statements of the Company for the financial year ended March 31, 2023 and the report of the Auditors thereon
3. Declaration of Dividend.
4. Re-appointment of Shri. Murugavel J (holding DIN:00605009), Director who retires by rotation, being eligible offers herself for re-appointment.
5. Approval for re-appointment of Smt. Akila Krishnakumar (DIN: 06629992) as Independent Director for a period of 5 years from August 10, 2023 till August 09, 2028
