Sub: Disclosure under Regulation 30

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Board of Directors at their meeting held today i.e. on 10th May, 2022 has approved the Project Capex for the expansion of Greenfield Sanitaryware plant and Brownfield faucetware plant.

The disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015, as amended are as follows:

a) existing capacity	Company produces Sanitaryware and Faucetware products. The present capacity of the Sanitaryware is 25 Lacs pieces p.a. and of Faucetware is 30 Lacs pieces p.a., which will vary from different products produced from time to time.
b) existing capacity utilization	Close to 90% - 100%
c) proposed capacity addition	Company will undertake capacity addition in phased manner. The phase 1 details are as under: For Sanitaryware - 12 Lac pieces p.a. (further expandable to 12 lacs pieces p.a. in phase 2, thereby aggregating to 24 lacs pieces p.a.) For Faucetware - 12 Lacs pieces p.a. (further expandable to 24 lacs pieces p.a. in phase 2, thereby aggregating to 36 lacs pieces p.a.) After completion of phase 1, the board will review the expansion for phase 2 for both, Sanitaryware and Faucetware.
d) period within which the proposed capacity is to be added	For Sanitaryware (Greenfield Expansion) - 24 to 30 months (Rs.128 Crore) For Faucetware (Brownfield Expansion) - 12 months (Rs. 69 Crores)

f) mode of financing	From Internal Accruals only, no debt raising is envisaged
g) Rationale	<ul style="list-style-type: none">- To increase share of high end SKU's.- To meet the quantity requirements for an expanding market over the medium term.- To mitigate the risk of production disruption at single location.- To achieve optimum cost of production by reducing overheads.
