We would like to update that above CP is a part of Rs. 100 Crores limit as approved by the Board of Directors in their meeting held on January 21, 2019 and shall be part of the existing working capital limit. We would like to further update that before this placement, the company had already placed commercial paper of Rs. 75 Crs. (due dates were 26-09-2019, 24-10-2019 & 17-12-2019) and necessary intimation was given to Stock Exchange on June 27, 2019, July 24, 2019 & September 17, 2019. Hence, after placement of above commercial paper, cumulative value of commercial paper stands increased to Rs. 100 Crs.

We would further like to inform that we have redeemed first trench of commercial paper amounting to Rs. 25 Crores on September 26, 2019. Hence, as on date, after said redemption of CP of Rs. 25 Crores and including placement of this tranche, outstanding commercial paper is Rs. 75 Crores (due dates are 24-10-2019,17-12-2019 & 20-01-2020).
