

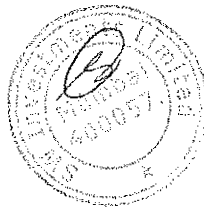

I, Veeraraghavan N., a Company Secretary in Practice had been appointed as the Scrutinizer by the Board of Directors of SW Investments Limited (CIN: L65990MH1980PLC023333) to scrutinizing the remote e-voting and e-voting process at the 42nd Annual General Meeting (“AGM”) in fair and transparent manner in respect of the resolutions as proposed in the Notice dated May 27, 2022 hereby submit my report as under:

1. The notice was sent to all the Members who were entitled to vote on the proposed resolutions as mentioned in the Notice for the 42nd AGM of the Company through electronic mode in accordance with the circulars issued by Ministry of Corporate Affairs.
2. The Company had published a notice in regard to dispatch of Notice through Email and E-voting information, as the case may be, in The Free Press Journal in English and Navshakti in Marathi Newspapers on August 02, 2022.
3. The Company had availed the e-voting facility offered by the National Securities Depository Limited for conducting remote e-voting and e-voting during the AGM by the shareholders of the Company.
4. The Shareholders of the Company holding shares as on cut-off date i.e. Wednesday, August 17, 2022 were entitled to vote on the proposed resolutions.
5. The remote e-voting facility was commenced from 9.00 a.m. on Saturday, August 20, 2022 to Tuesday, August 23, 2022 at 5.00 p.m.
6. The shareholders attending the AGM through VC / OAVM who had not cast their vote through remote e-voting could cast their vote for a period of 15 minutes after the conclusion of the AGM.
