Air India Extends Suspension of China, HK Flights till June

MUMBAI National carrier Air India has cancelled its flights to China and Hong Kong till June due to Covid-19 outbreak, reports Our Bureau. The airline had earlier cancelled flights till March-end, but has extended it till June. Meanwhile, airlines from China are also not operating full flights to India. However, flights from Hong Kong continue to fly to India, carrying about 400 passengers daily, who are being checked at airports for the novel virus.

Ajay Devgn Ad for Dabur, HUL Rexona Get ASCI Fiak

MUMBAI Actor Ajay Devgn's ad for Dabur Babool Ayurvedic Paste and Hindustan Unilever's campaign for Rexona Whitening were among the marketing efforts found as "misleading" by Advertising Standards Council of India (ASCI), a self regulatory body of advertisers. The Dabur campaign on TV and the Rexona campaign on social media, which alleges that ordinary white toothpastes are cheating consumers and the cheating will stop using its toothpaste, a statement by ASCI said.

Fixed Broadband Speed Dips in India in January: Ookla Report

NEW DELHI Mean download speeds on fixed broadband network in India slipped to 38.84 megabit per second (Mbps), but the same on mobile network improved slightly to 11.58 Mbps in January, a report released by Ookla said on Thursday. Ookla's Speedtest Global Index compares internet speed data from more than 200 test locations each month, and the data for same comes from tests taken by people using Speedtest application.

JLR Shelves Plan to Sell US Dollar Bonds to Raise Cash

LONDON Jaguar Land Rover Automotive has shelved plans to issue a US dollar bond after investors demanded too high an interest rate to compensate for the risk the coronavirus poses to the luxury carmaker, according to people familiar with the matter. Jaguar hired Bank of America Merrill Lynch to meet investors in the US last week ahead of a potential sale of new bonds, and days after warning the deadly virus outbreak was impacting its supply chain.

Investments in Fintech Cos Doubled to \$3.7 billion in 2019

NEW DELHI Investment in financial technology (fintech) ventures in India nearly doubled to \$3.7 billion in 2019, making the country the world's third largest fintech market, as per an Accenture analysis of data from CB Insights. The number of deals was up slightly to 198 last year from 193 in 2018, it added.

Investments in payments companies more than tripled, while funding into insur-tech rose 74% to \$510 million. Investment in fintech firms rose sharply in most major markets in 2019 led by gains in the US and UK and EMs such as India and Brazil, it said.

Profiteering Charge on Nestle: HC Stays NAA Order on Unpaid Fine

Authority had imposed a ₹90-c fine on Nestle for not passing on GST cut gains to consumers

New Delhi: The Delhi High Court has given interim relief to Nestle India by ordering stay on the payment of outstanding penalty that the National Anti-Profiteering Authority (NAA) had directed the local arm of the Swiss fast-moving consumer goods firm to pay. In its order dated February 10, the court said the company had already paid ₹16.58 crore out of the total demand of ₹69.73 crore and clamped a stay on the recovery of the balance amount.

This interim order shall not come in the way of the National Anti-Profiteering Authority in cases where it has suo moto taken action," said the court. "We also observe that prima facie, it appears to us that the limitation of period of six months provided in Rule 13 of the CGST Rules, 2017 within which the authority should make its order from the date of receipt of the report of the Directorate General of Anti-Profiteering, appears to be directory in as much as no consequence of non-adherence of the said period of six months is prescribed either in the CGST Act or the rules framed thereunder."

In December 2019, the NAA had upheld allegations of profiteering against Nestle India on the grounds that it had not passed on the benefits of reduction in goods and services tax (GST) rates of its various products to consumers. It had ordered the company to pay about ₹69 crore.

The NAA had said that the methodology adopted by Nestle to pass on GST rate-cut benefit was "highly arbitrary and illegal, which has resulted in unfairness and inequality while passing on the benefit of tax reduction."

Nestle had also challenged the NAA order on the grounds that the order suo moto and not on the basis of written complaint which was impermissible. Further, the company had said while the matter was heard by four members, the NAA order was signed by only three members, and that the order was passed beyond the mandatory period of three months.

Nestle had already proposed a ₹16 crore in the consumer welfare fund last year on a voluntary basis.
