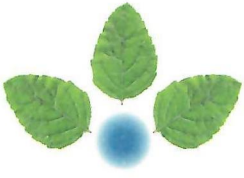
The equity shares so allotted under the Scheme shall rank *pari-passu* with the existing equity shares of the Company in all respects including dividend.
