The Postal Ballot Notice was dispatched to all the shareholders of the Company on April 27, 2024, in due compliance with the provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, the Companies Act, 2013 and the rules made thereunder, read with circulars issued by the Ministry of Corporate Affairs. This corrigendum to Postal Ballot Notice dated April 26, 2024 ("Corrigendum") shall form an integral part of the Postal Ballot Notice, All contents of the Postal Ballot Notice, save and except as modified by this Corrigendum, shall remain unchanged.

Pursuant to the correspondence with National Stock Exchange of India Limited, in relation to the In-principle approval sought by the Company from the Stock Exchange for the Preferential Issue under Regulation 28(1) of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015, the Company through this communication wishes to bring to the notice of the Shareholders, the changes in the said Postal Ballot Notice as mentioned hereunder:

All capitalized terms used herein and not specifically defined shall have the same meaning as ascribed to such terms in the Postal Ballot Notice.

#### Changes to the Explanatory Statement to Item No. 1.

### 1. Para (1) of Point no. (d) is modified and shall be read as under:

The Equity Shares of Company are listed on Stock Exchange i.e. BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE") (together referred to as the "Stock Exchanges"). The Equity Shares are frequently traded in accordance with SEBI ICDR Regulations. For the purpose of computation of the price per Equity Share, NSE being the stock exchange with higher trading volumes for the preceding ninety trading days prior to Relevant Date i.e. April 26, 2024, has been considered for determining the floor price in accordance with the SEBI ICDR Regulations.

#### 2. Point no. (s) is modified and shall be read as under:

As per Regulation 163(2) of the ICDR Regulations, the Company is required to place a copy of the certificate of a practicing company secretary before the shareholders considering the proposed Preferential Issue, certifying that the issue is being made in accordance with the requirements of SEBI ICDR Regulations. Accordingly, a revised certificate from Mr. Kashyap Shah (FCS No. 7662) of M/s Kashyap Shah & Co. Practicing Company Secretaries dated May 06, 2024, incorporating change as to "the highest trading volume in respect of the equity shares of the Issuer has been recorded during the preceding 90 trading days prior to the relevant date on NSE" has been obtained by the Company. The copy of the said certificate shall be made available for inspection by the members during business hours on all working days upto the last
