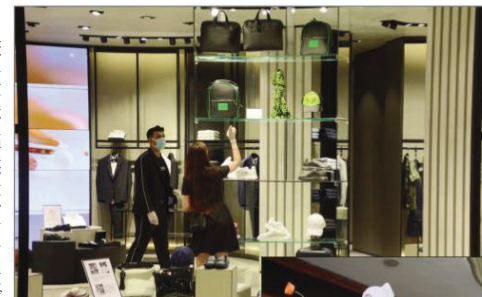
Thane Ganpati immersions:

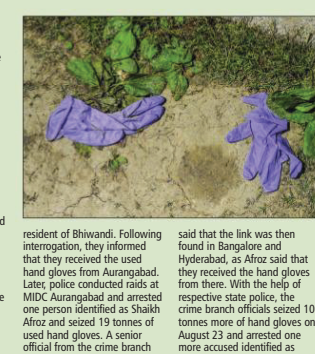
