

**To the Board of Directors of Shree Ganesh Bio-Tech (India) Limited**

1. We have reviewed the accompanying Statement of unaudited Standalone financial results of **Shree Ganesh Bio-Tech (India) Limited** for the quarter ended 30 September 2023 ("the Statement") being submitted pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (Listing Regulations).
2. This Statement, which is the responsibility of the management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations.
