Accordingly, compliance with regard to appointment of Director (Finance) was made on May 02, 2023. The Company has been complying with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 issued by SEBI from time to time.

Reply with reference to your e-mail dated September 22, 2023 regarding the following discrepancies:

- Explanation for delay not provided for disclosure made under regulation 30(6) of SEBI (LODR) Reg., 2015 after 24 hours of occurrence of the event or information Reply: Since there was a system failure at our end the same could not be intimated. However, compliance was made on next day i.e., May 26, 2023.
- Full details not provided as per SEBI Circular dated September 09, 2015 for change in Director/KMP/Auditor/Compliance Officer (Reason/Date/profile/Relationship) Reply: Since Director (Finance) was appointed as Chief Financial Officer (CFO), the brief profile of Director (Finance) was already submitted to the Exchange on May 02, 2023, It was assumed that, the details of the CFO might not required to be submitted on May 26, 2023 since the appointee was the same person.

Further, we assure that adequate measures will be taken in future to elimiate such technical error. We also regret the inconvenience, if any, caused in this matter.
