New Delhi: The committee on Minimum Support Price (MSP) held a broad discussion on Monday, including making MSP more effective and transparent' in its first meeting on Monday. The committee, headed by former agriculture secretary Sanjeev Agarwal, discussed various ways to promote more budgetary farming, change patterns of sowing in view of the changing needs of the country, and to make MSP more 'effective and transparent'.

97-yr-old challenges Senior Citizens Act

New Delhi: A 97-year-old man has approached the Delhi high court challenging certain provisions of the law that give benefit to the aged persons to get declared the property transferred to their children as well. In case they are not able to do so.

The petition has challenged the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 under which a senior citizen, who after the commencement of the law has transferred his property to another person, subject to the condition that the transferee will care of the circumstances and basic physical needs of the transferor.

SGM, which necessitated settling up of a trust, was filed by 97-year-old Bapuji after losing his wife. He protest against the farmers' protest against farm laws and forcing the government to repeat them, has already rejected this committee and decided not to nominate its representatives on.



The court issued notice and sought a response of the Centre on the petition.

However, the benefit is not provided to those who have transferred their property to another person, subject to the condition that the transferee will care of the circumstances and basic physical needs of the transferor.

As per the provision, if

the transfer of property is deemed to have been made by fraud or coercion or under undue influence and the transferor is denied this valuable benefit of having the transfer declared as valid, it is said.

A bench of Chief Justice SA Bobde, Chaudhury Shreeram and Justice Subramanian. Pre-issued notice and sought a response of the Centre on the petition. Thereafter listed the matter for further hearing on December 15.

The petition, filed through advocate Sudarshan Ranjan and Mahesh Kumar said two of the petitioner's sons transacted legal documents signed by him in respect

of certain portions of his property here in May 2007 and now even the rent from those portions has been taken away by the sons.

It said after the execution of the gift deed, the Central government notified the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 and it came into force in September 2008.

"Hence the Act was notified and brought into force slightly earlier, the petitioner too would have been covered under the Act," it said.

Heavy rains lash MP, Raj; water level in Odisha rivers in spate

Village chief who alerted all dies in landslide

Shimla: When extremely heavy rainfall lashed Himachal Pradesh's Mandi district, village chief Kishan Singh sent messages on WhatsApp to several other farmers warning them of landslides. CM Jai Ram Thakur, after visiting flood-affected areas in Mandi district, announced that Singh's house would be reconstructed by the administration. Twenty-two people were killed, twelve injured and five feared dead as they went missing in 36 incidents of landslides and flash floods triggered by heavy rainfall across Himachal Pradesh on Saturday. Thakur also announced that the state government will provide Rs 4 lakh to next of kin of the deceased who lost their lives in the landslides and flash floods.

Rivers, drains and other water bodies were in spate in large parts of the state and gurus of some streams were reported to release water. Less vehicular traffic was witnessed due to poor visibility on many roads, especially in western MP.

In northern Odisha, the flood situation was alarming on Monday as the swollen Brahmaputra river inundated low-lying areas and left people in over 100 villages marooned, officials said. The water level in all the rivers located in north Odisha is in spate due to heavy rain caused by a deep depression over

the Bay of Bengal, and subsequent flood water release from Brahmaputra.

Authorities in Balasore and Ganjam districts had on Sunday launched a massive evacuation drive to shift people from vulnerable areas to safer locations, they said.

Nearly 165 villages in 33 gram panchayats in Balasore district have been hit by the flood. The administration has evicted 40,000 people by Monday noon, and they are housed in 27 temporary shelters.
