### दरातील ३ टक्के कपातीचा परिणाम

राज्यात २२ मार्चपासून लॉकडाऊन लागू झाले. याचा परिणाम सर्व क्षेत्राप्रमाणे



मालमत्ता बाजारपेठेला व पर्यायाने मुद्रांक शुल्क वसुलीवरही झाला. इतिहासात पहिल्यांदाच राज्याला सर्वात कमी, ३ कोटी ९४ लाख इतका महसूल मिळाला. इतर वेळी राज्य महिन्याला १ हजार ५०० ते २ हजार कोटी रुपयांचा महसूल मुद्रांक घरखरेदी, भाड्याने घर आणि इतर

एप्रिलमध्ये मिळालेला महसूल चिंता वाढवणारा ठरला. मे महिन्यातही मुद्रांक शुल्क वसुली जेमतेमच राहिली. यानंतर मात्र मुद्रांक शुल्क भरणाऱ्यांचे प्रमाण,
